

**RESOLUTION NO. 4 of 2023**

**AMENEDMENT OF RESOLUTION 23 of 2022  
ACTING ON THE APPLICATION OF JUAN TULA TOMAX  
FOR THE PROPOSED INTERMUNICIPAL TRANSFER OF A  
PENNSYLVANIA LIQUOR CONTROL BOARD RESTAURANT  
LIQUOR LICENSE NUMBER R-7744  
TO THE PREMISES AT 701 SOUTH WALNUT STREET  
IN THE CITY OF NANTICOKE, LUZERNE COUNTY, PENNSYLVANIA**

**WHEREAS**, Juan Tula Tomax applied to the City of Nanticoke, Luzerne County, Pennsylvania, for approval of an intermunicipal transfer of Pennsylvania Liquor Control Board Restaurant Liquor License R-7744 to the premises located at 701 South Walnut Street, Nanticoke City, Luzerne County, Pennsylvania; and

Glassberg, has informed City Council that the correct name for Applicant is Mama Italian Pizzeria LLC for the premises located at 701 South Walnut Street, Nanticoke City, Luzerne County, Pennsylvania, and that the current licensee/transferor of Pennsylvania Liquor Control Board Restaurant Liquor License R-7744 is Krishna & OM, LLC with a registered office at 104 Kimberly Drive, Duryea, Luzerne County, Pennsylvania. All other information previously submitted is the same.
