A Motion to approve Ordinance # 3 of 2024, (Second Reading), AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF NANTICOKE AMENDING CHAPTER 485-6(A) OF THE CITY OF NANTICOKE CODE OF ORDINANCES TO AMEND THE DEFINITION OF COMMERCIAL VEHICLE AND AMENDING CHAPTER 485-48 PROHIBITING PARKING ON PROSPECT STREET IN CERTAIN LOCATIONS AND AMENDING CHAPTER 485-56(A) TO ADD AN ADDITIONAL DESIGNATED RESIDENTIAL PERMIT PARKING AREA IN THE CITY OF NANTICOKE ON ARCH STREET BETWEEN NORTH WALNUT AND BROADWAY STREET.
