Mayor Kevin Coughlin executed **Executive Order # 14 of 2025**, appointing Scott Gartley, Esquire of the law firm Knoff, Mangan and Gartley as Labor Council for the City to provide legal advice and representation on labor matters in order to support the effective administration of labor functions of the City of Nanticoke.

Mr. Krieger asked that the police department place the digital speed sign back on Hanover Street because that deterred people from speeding. President Brown stated Chief Mike Roke will be asked to place the speed sign back on Hanover Street for now.
