City Manager, Donna Wall has updates for Council.

3. Large sinkhole in alleyway of Kosciuszko was repaired and a new catch basin was installed.

COMMENTS FROM THE PUBLIC –

Sandra Dudrick- of 535 East Union Street, stated that she was here to try to improve our town. Mrs. Dudrick commented on the many buildings that are eye sores on Main Street that need attention, including grass maintenance. Mrs. Dudrick questioned if there was a code book and if we advertised for low-income housing. She also questioned the status of the properties on Main Street and Donna Wall, City Manager, answered as follows:

1. Falling down wall, owned by Dr. Pilarek- Jonathan Lang, Code Enforcement will follow up.
2. 1st National Bank building- Bids are being taken by the Municipal Authority to demolish the building.
3. Other Bank on Main has garbage and animals- Jonathan Lang, Code Enforcement will follow up.
4. House on Main and Jifkin (Appliance Store)- we were in negotiations to acquire building and now that the father and son passed, the property is in probate.
5. Nardozzo's Pizza and buildings surrounding Nardozzo's Pizza- the case went to the Supreme Court and due to technicalities, it has been held up. Slusser Law firm is handling the situation.
6. Bowl-a-rama- Buyer backed out and the Municipal Authority is seeking new buyers.

Jack Dudrick- of 535 East Union Street, questioned why there isn't a better way to address and correct the problem with property maintenance in our City. Attorney Rachel Finnegan said she would look into another way to correct problem. Donna Wall, City Manager, stated a lot of properties have LLC as landlords and the landlords themselves are hard to find. The City does require property managers for out-of-town landlords, inspections, and we formed a Landbank to help with these issues. We do our best but sometimes our hands are tied.

Mr. Dudrick also stated and questioned the following and Donna Wall, City Manager, replied as below:

1. Two streets need to be paved, College from Green to Main and East Union Street by the school- the City is in the process of working on those streets. CDBG East Union street improvement project has had the grant awarded and we are awaiting the documents, and we are working on funding for College Street.

2. The street department is not using the cold patch the correct way, and it is washing away- Rick Josefowicz, DPW foreman, will follow up,
3. Can't we do something about utility pave cuts? Requested that someone inspect the final product before approval. – We will look into it.
4. I have questioned Jonathan Lang about the laundry on Main Street, and he has stated that we do not have any ordinance to address it. Do you have an ordinance to address it? - No, we do not.
5. The City is doing a good job with the celebration of 250/100 years, but we need signs to promote the event.

Joni Turner- of 229 East Spring Street questioned as follows about the new noise ordinance:

1. Will the noise ordinance be available in Spanish? - Donna Wall, City Manager, replied that the City is not required to publish in Spanish, but we could provide it.
2. What happens when something new is passed? How is it dispensed? Donna Wall, City Manager, it is available on our website.
3. How do we make landlords responsible? - Mark Boncal, Fire Chief said that there are guidelines for rental properties.
4. Can you video a noise issue that comes up? How about fireworks, vibrations from mufflers? How can a resident be cited– Michael Roke, Police Chief addressed these questions and said that you can record in a public place and call anytime to report an incident. The calls are dealt with on a case-by-case basis. There is public record of how many times someone has been cited. Please be aware that there are only 2 officers on a shift and unfortunately noise incidents do not take precedence over traffic details.
5. Are there any laws on how church bells ring? Attorney Rachel Finnegan stated that she will look into it.
