#### COMMENTS FROM THE PUBLIC -

Mr. John Zendarski requested a copy of the 2025 Budget and asked who he can speak to if he has any questions and Jennifer Polito replied she will have a copy ready for him to pick up on Thursday and he could speak to her or Donna Wall. Mr. Zendarski asked why Wilkes Barre residents pay their garbage by bag with a sticker for only \$3; that would be much better for him who only puts out one bag per week. President Brown stated Wilkes Barre residents pay a fee up front plus the \$3 per bag. Mr. Zendarski stated he knows someone that could get the city a good deal on garbage trucks so the city could collect their own refuse and President Brown stated it is not the cost of the trucks, its addition DPW personnel, landfill fees, insurance, maintenance on the trucks and other expenses that makes it very costly to collect refuse. President Brown stated we used to collect our own but it got too costly. Mr. Zendarski asked Council what is the city's crime rate with all this Fentanyl on the streets and President Brown replied Chief Roke is normally at the Council meeting but he is on vacation so we will have that answer for the next meeting. Vice President Nalepa replied the Fentanyl issue is a national epidemic not just an issue in this area. Mr. Zendarski commented that the city needs to do more to hold the absentee property owners liable for keeping up their properties and have proper numbering of the houses. President Brown replied Code enforcement is on this issue every day. Donna Wall stated all addresses are up to date with 911. Mr. Zendarski informed Council he switched his political part to Independent, therefor, he has until August 1, 2025 to file his paperwork with the Bureau of Elections.

**Mr. John Telencho** asked Council for a current update on the Nanticoke Hospital property. Chief Boncal replied a New York owner acquired the property for approximately \$200,000 on an online auction and tried to reopen the hospital as a cardiac care unit and nothing ever happened. Chief Boncal stated due to not paying the bills, all utilities have been shut off to the property and the building is completely vacant. Mr. Telencho asked what happens now, are we in a situation like the Bowlarama? Chief Boncal replied see if the owner is paying the taxes and if not, the city can try to get the property on a Tax Sale. Mr. Telencho asked if the rumor that the SPCA bought Dundee Gardens is true and Donna Wall replied yes.
