ADMINISTRATIVE UPDATES:

Mayor Kevin Coughlin has submitted the April 2025 Department Reports for Council's review and Jennifer Polito has posted them on the City's website at www.nanticokecity.com.

Mayor Kevin Coughlin executed <u>Executive Order # 10 of 2025</u>, appointing Nicole Mackiewicz to the Nanticoke City General Municipal Authority pursuant to Article VII, Section 7.01 of the City of Nanticoke's Home Rule Charter.

City Manager, Donna Wall had the following updates for Council:

- 1. The city received an LSA Grant in the amount of \$174,000 to repair the back parking lot and retaining wall.
- 2. All Street lighting in Nanticoke has been switched to LED lights as part of a UGI project except for a few in Honey Pot which will be completed soon.
- 3. The water company will be in town to repave their pave cuts.

A Motion was made by Councilmember Nalepa seconded by Councilmember Dougherty to adjourn the work session.

Motion carried unanimously.

Ms. Kierstyn Hulse questioned the proposed zoning amendment in Ordinance #9 of 2025 regarding the height limit on fences and wanted to know if exceptions would be made for people like her that have uneven property lines. City Manager, Donna Wall explained the payables figure is high due to two grants the city received in their name on behalf of the school district. The city had to send the school district \$900,000 in grant funds received.
