**Mayor Kevin Coughlin executed Executive Order # 11 of 2024**, appointing Christina L. Josefowicz to the General Municipal Authority of Nanticoke pursuant to Article VII, Section 7.01 of the City of Nanticoke's Home Rule Charter.

**City Manager, Donna Wall had the following updates for Council:**

- Donna introduced Olivia Dougherty who was an intern at the City today helping Donna Wall and Jennifer Polito with various tasks and Donna stated it was a pleasure to have her as an intern.
- RLE will be done with all water line replacement work by April 19, 2024.
- Base restoration on the streets by Stafursky is almost complete with two streets remaining.
- Stafursky started the ADA Ramps on 4-17-2024.
- Milling and Overlay is scheduled to start on 4-18-2024, weather permitting.
- The Main Street "Street Scape Project" is moving forward and is running ahead of schedule .
- Saturday, April 20, 2024, 10 am to 2 pm, NEPA Rogi will be having their Grand Opening celebration with various events held in Patriot Park and a Ribbon Cutting at 12 noon.
