#### **COMMENTS FROM THE PUBLIC –**

**Mr. John Zendarski** of 170 W. Ridge Street inquired about holding a "Meet and Greet" for the new candidates running for election after an upcoming meeting at City Hall and Vice President Nalepa replied he cannot hold a meeting on City property. Mr. Zendarski asked where did Vice President Nalepa get that statement from; he would like to see it in writing. Attorney Rachel Finnegan replied she just came across that information recently for a different municipality, so she will look into getting Mr. Zendarski the information he has requested.

Ms. Audrey Williams of 523 Jones Street has concerns of public safety and extreme noise from a neighbor on her street. Ms. Williams stated a neighbor is constantly ripping and tearing up and down her street with a quad and he is going to hurt someone. Vice President Nalepa asked what time of day does this go on and is it a kid or an adult. Ms. Williams replied 8 am to midnight and it is an adult. Ms. Williams stated he has a Mustang with a very load muffler and she wanted to know if the city had a noise ordinance. Chief Roke stated the city does not have a noise ordinance. Chief Roke will have the Police Officers patrol more frequently on her street. Ms. Williams has footage on her ring camera of his actions at 1:30 today and Chief Roke asked that she bring the footage on a thumb drive to him on Thursday or email it to me and will issue a citation. Sandra, a city resident, stated the police will not do anything about the noise, she called the police about a load party that was 72 decimals late one evening and the cop told her to go to bed.

Mr. Mike Marcella of 240 E. Church Street asked who in the city is responsible for tracking the repairing of the pave cuts done by the utilities? Mr. Marcella stated there are a lot of patches in the roads that are sinking and need to be fixed. Vice President Nalepa stated Rick is contacted when the pave cut is going to be done but he is not sure who follows up on the repairs. Mr. Marcella stated the city should have a log tracking the pave cuts from the time the utilities cut up our roads to when the road is fixed and someone should be following up on it. Ann Gryzmski stated the Utilities fill out a pave cut application with the code office and if a patch is sinking, please call Rick. Jennifer Polito stated the Utilities patch their cuts until they are done with the entire project then come back into town to repave the streets that have pave cuts.
