Mayor Coughlin stated the City Officials and Administration are getting a lot of complaints regarding the city's Refuse Fee. Mayor Coughlin nominated Vice President Telencho to form a committee with prior election candidates and city residents to research better Refuse options for the upcoming years for when the contact with JP Mascaro ends at the end of this year. Mayor Coughlin stated that this all needs to be resolved for the 2027 Budget and Finance Director, Jennifer Polito stated the mayor is correct and that a solution with the cost would have to be submitted to her by the end of August in order to give Council a preliminary budget in September.

Councilmember Comments-

Vice President Telencho thanked the mayor for his confidence in nominating him to form a committee for the refuse issues. Vice President Telencho commented that the DPW Department should get ready for the snow storm this weekend.

Councilmember James thanked all of our essential services workers for their services and is hopeful in finding a better solution for the issue of the cost of the garbage collection.

Councilmember O'Connor is also hopeful that the committee will come up with a way to reduce the costs of our garbage collection and commented that the DPW Department did a great job with the last storm.

Councilmember Butczynski thanked Kevin for coming up with this great idea to tackle the cost of garbage collection. Ms. Butczynski stated we all pay the garbage fee and we may not like it but it has to be done.

President Dougherty commented that the DPW did a great job on the roads during the last storm. President Dougherty thanked the Nanticoke Ambulance for the annual report they submitted to Council and noticed they had less calls and this is due to more transports of more sick people out of the area so the turn around tie is longer.

Mr. John Kreiger commented on the city's garbage collection issue and the need to find a solution to reduce costs.
